(A) Prior to Town Meeting, both the Board of Selectmen and the Advisory Committee approved a revised version of TMM Marty Rosenthal's proposed Traffic Calming amendment. Both bodies approved \$50,000 for Traffic Calming and \$1,000,000 for Street Rehab. Town Meeting also approved the \$50,000 for Traffic Calming and \$1,000,000 for Street Rehab: "Raise and appropriate \$50,000, to be expended under the direction of the Board of Selectmen, with input from the Transportation Board and Commissioner of Public Works, for Traffic Calming studies and improvements; provided that the Department of Public Works and Transportation Board provide status reports to the Board of Selectmen on a semi-annual basis."

(B) 1-10 Auburn Ct. is included in the new zoning district.
