Town Meeting approved the Advisory Committee's motion.
- (2) Town Meeting adopted Marty Rosenthal's amended to remove the word "civilian" before both the "Police Commissioner" and "Fire Commissioner". ("Civilian" was added by the Selectmen and Advisory Committee as part of their vote.)
- (3) The Spiegel Amendment (http://www.brooklinema.gov/index.php?option=com_docman&task=cat_view&gid=751&Itemid=654) makes the article subject to local referendum. Town Meeting adopted the Advisory Committee's motion (no Spiegel amendment).
- (4) The Selectmen and Advisory Committee had different motions. Town Meeting adopted the Selectmen's motion.
