(A) Neither the Goldsmith nor the Hyatt amendments were approved by the Selectmen, Advisory Committee, or Town Meeting.

(B) Article 1 of the "Special Town Meeting within the Special" was approved, naming the athletic fields at Cypress St. Playground the "Thomas P. Hennessey Fields at Cypress St. Playground" without the sunset clause that was part of Article 14.

(C) Prior to the commencement of Town Meeting, both the Selectmen and the Advisory Committee voted against the Petitioner's proposed Resolution.

(D) The Selectmen's and Advisory Committee's votes differed. Prior to the commencement of Town Meeting, the Selectmen voted against the revised motion of the Advisory Committee. Town Meeting voted against the Advisory Committee's language (145-19-8) and adopted the language offered by the Selectmen.
